TEMPORARY PROHIBITION OF THROUGH TRAFFIC

DEVON COUNTY COUNCIL hereby give **NOTICE** that:

From **TUESDAY 25 AUGUST 2026**
for a maximum of 5 days

Until **SATURDAY 29 AUGUST 2026** (both dates inclusive)

Between the hours of **07:00** and **19:00**

No person shall cause or permit any vehicle to proceed on the sections of Affected Roads.
